In addition to residency requirements for TEG, continuing students are required to maintain a minimum cumulative GPA (grade point average) of **2.50**; successfully complete a minimum of **24** semester credit hours (18 credit hours if a graduate student) in each academic year (i.e., Fall 2011, Spring 2012, Summer 2012); and maintain **Satisfactory Academic Progress** as outlined in the LETU catalog, and be enrolled at least **¾ time each semester** (9 credit hours for undergraduates, 6 credit hours for graduate students).
