



## Admission Requirements to the Educator Preparation Program for All Undergraduate Educator Certification Programs

In order to be formally admitted into the LeTourneau University Educator Preparation Program (EPP), students need to have completed the following.

1. Admission to LeTourneau University academic program.
2. Completion of a course sequence and degree plan in conjunction with the major advisor and teacher education advisor.
3. Overall GPA of at least a 2.5. Overall GPA is calculated to include all coursework completed at all colleges and universities without regard to whether the courses were transferred into LeTourneau.
4. Completion of a minimum of 45 semester credit hours on the degree plan with a minimum of 9 semester hours of EDUC or READ taken at LeTourneau and a minimum cumulative 2.5 grade point average. (Those without the 9 hours of EDUC/READ may be admitted with the recommendation of their advisor and the approval of the program chair.)
  - Candidates desiring to teach in grades EC-6 must have completed at least 12 semester hours in their major.
  - Candidates desiring to teach in grades 7-12 must have completed at least 12 semester hours in their major.
  - Math and Science candidates must have completed 15 semester hours.
5. Demonstrate basic skills in reading, written communication, and mathematics through one of the following:
  - Completion of coursework equivalent to ENGL 1013, ENGL 2393, and Math 1123 with a C or better
  - Completion of an associate degree
  - Transfer transcript indicating TSI Complete
  - Military service as follows:
    - Active duty for at least three years preceding, or
    - Honorable discharged, retired or released from active duty on or after August 1, 1990
  - Completion of one of the tests below

6. Complete an admission application. When all parts of the application and \$55 application fee are submitted, the application will be processed and submitted to the program chair for consideration.
7. An email with an invitation for admission will be sent to those who meet the qualifications. Once the invitation is signed and returned, clearance to continue with EDUC/READ courses is granted.

### Criminal Records:

- Acknowledgement:** The State Board for Educator Certification (SBEC) shall obtain from any law enforcement or criminal justice agency all criminal history record information that relates to an applicant for or holder of a teaching certificate (Texas Education Code §22.082).

All applicants for Texas teaching certificates will be screened for a record of felony or misdemeanor convictions through the Texas Department of Public Safety (DPS) (Texas Government Code §411.090). Since October 1, 2003, SBEC has required applicants for an initial credential, including a standard certificate, probationary certification, educational aides, one-year certificate or permit, to undergo a national criminal background check by submitting fingerprints for review. SBEC sends the applicant's fingerprints directly to the Texas DPS for a state and national review.

- Notice:** All potential certificate applicants with criminal felony or misdemeanor convictions should contact the certification officer immediately to seek clarification of their prospective certification status.

### Clinical Teaching/Internship

All students seeking an undergraduate degree and teacher certification through LeTourneau University who are admitted to the Educator Preparation Program prior to graduation will register for and successfully complete either clinical (student) teaching or an internship. No student admitted to the Educator Preparation Program at LeTourneau University will be recommended for certification through emergency certification or temporary certificates.

### Disclosure

Disclosure of your Social Security number (SSN) is requested from you in order for LeTourneau University to provide the number to the State Board for Educator Certification (SBEC) as mandated by SBEC internal rules. Your SSN will be used by the SBEC in order to process applicant certification. No statute or other authority requires that you disclose your SSN for that purpose. Failure to provide your SSN may, however, result in your inability to complete certification requirements for Texas educators. Further disclosure of your SSN is governed by the Public Information ACT (Chpt. 552, Texas Gov't Code) and other applicable law.

To be accepted into the LeTourneau University's Educator Preparation Program, the following must be complete:

- Minimum of 45 semester credit hours with 9 hrs EDUC/READ at LETU and a minimum cumulative GPA of 2.5 **OR** recommendation of advisor and approval of the Program Chair
- 12 semester hours in major with a minimum GPA of 2.5. (Please note that candidates for Math and Science must have completed 15 semester hours.)
- Basic skills in reading, written communication, and mathematics (Refer to #5 on cover page of application.)
- Submit \$55 TEA Admission fee made payable to LeTourneau University

I understand that once my application has been received and completion of above items verified, I will be contacted through my LETU email address regarding EPP admission. In order for the admission process to be completed, I must return the formal offer of admission within seven days.
